

**P8 - Bylaw No. 169**

**The Summer Village of Sundance Beach**

**A BY-LAW OF THE SUMMER VILLAGE OF SUNDANCE BEACH TO IMPOSE CERTAIN RESTRICTIONS ON THE USE OF MUNICIPALLY OWNED PROPERTY**

**WHEREAS** the Council considers it necessary and expedient to initiate certain controls and restrictions on municipally owned property within the boundaries of the Summer Village; and

**WHEREAS** the Municipal Government Act delegates the authority to Council to control public property and/or places;

**NOW THEREFORE**, the Council of the Summer Village of Sundance Beach, duly assembled, enacts as follows:

1. Overnight camping on any of the above-described property shall be strictly prohibited.
2. Parking of any mobile travel units, tents, holiday trailers, campers or any other type of recreational camping units on the above-described property is strictly prohibited.
3. Any type of open fire on the above-described property shall be strictly prohibited unless authorized by Council in writing.
4. The Council of the Summer Village of Sundance Beach may prohibit any uses that are deemed to be obnoxious, a nuisance, or prejudicial to the Summer Village or its residents.
5. The cutting of brush, trees, or the damaging of other natural growth is strictly prohibited unless authorized by Council in writing.
6. Any person violating the provisions of this By-law and who has been issued an official tag by the Official Law Enforcement Agency for breach of same, may avoid prosecution by paying direct to the Municipal Administrator at the Village Office, within seven days of the issuance of this tag, the following amounts:

1 <sup>st</sup> Offence	\$100.00
2 <sup>nd</sup> Offence	\$250.00

This By-law shall come into force upon the passing thereof. Upon passing of this By-law, By-law No. 25 and By-law No. 37 are hereby repealed.

READ a first time this 12<sup>th</sup> day of August, A.D. 1999

READ a second time this 16<sup>th</sup> day of September, A.D., 1999

READ a third time and finally passed this 16<sup>th</sup> day of September, A.D., 1999
