**A BYLAW OF THE SUMMER VILLAGE OF SUNDANCE BEACH, IN THE PROVINCE OF ALBERTA, TO REPEAL AN INTERMUNICIPAL COLLABORATION FRAMEWORK WITH LEDUC COUNTY**

---

**WHEREAS** Pursuant to 708.28(1) of the Municipal Government Act, municipalities that have common boundaries must create a framework unless they are members of the same growth management board; and

Pursuant to 708.32(1) of the Municipal Government Act, the municipalities that are parties to a framework must review the framework at least every 5 years after the framework is created, or within a shorter period of time as provided for in the framework.

Pursuant to 708.33(1) of the Municipal Government Act, municipalities that are parties to the framework must each adopt a bylaw or resolution that contains the framework; and

The Councils of the Summer Village of Sundance Beach and Leduc County wish to streamline processes by approving the frameworks by resolution and therefore the Summer Village of Sundance Beach wishes to repeal the Intermunicipal Collaboration Framework with Leduc County (Bylaw 2019-03).

**NOW THEREFORE** be it resolved that the Summer Village of Sundance Beach, duly assembled, enacts as follows:

1. That the Leduc County and the Summer Village of Sundance Beach Intermunicipal Collaboration Framework Bylaw No. 2019-03, attached as ‘Schedule B’, is repealed upon this bylaw coming into force.
2. This bylaw shall take effect on the date of third reading.
